During the 2016-17 school year, Planned Parenthood of Montana (PPMT)'s goal was to increase the number of presentations given and students reached through peer education.

Objective I: PPMT's Outreach Educator will recruit ten students volunteers for Billings Teen Council.

Results: PPMT had 9 members during the 2016-17 school year. The Outreach Educator received nine new applications in the spring of 2017 for the upcoming 2017-18 school year, with six volunteers who showed up for interview night. PPMT accepted all six into the program. With the additional six returners, PPMT will have twelve Teen Council members for the upcoming school year.

Objective II: The Billings Outreach Educator will train and work with participants to create formal presentations for high school students that are engaging, educational, accurate, fun and age appropriate.

Results: Thirty-three weekly meetings were held between September 2016 and May 2017. Teen Council members were trained on sexual health topics. Lesson plans were developed on health relationships and consent to present to local high school students.

Objective III: Conduct education and outreach to 650 teens in Billings, MT between February and June 2017.

Results: Teen Council members presented 42 times in classrooms, including all three public high schools in Billings, and reached 1288 students.

Billings Teen Council successfully met the goal of increasing the number of presentations as well as increasing the number of students reached. In order to accomplish this goal, presentations started at the beginning of the school year with students from West High School's freshman health classes. Teen Council members presented the lesson on Healthy Relationships in the fall and then the lesson on Consent in the spring. In addition, Teen Council members were invited into teacher's classrooms who had not previously had Teen Council present before.

Teen Council continues to impact both Teen Council members and high school students through presentations and one on one interactions with friends and family. Knowledge about sexual health, relationships and consent is an important part of becoming an adult and making responsible decisions. Interest and support in the Teen Council continues to grow in the Billings community. Feedback from teachers and parents has been extremely positive.

I am reaching out in support of the Billings Teen Council and to thank you for the awesome work you all are doing! It was such a pleasure to have the Teen Council join my high school science classes earlier this month for a student-led presentation focused on the topic of Consent . This presentation was created and facilitated by Teen Council members and it was extremely student-centered in nature which made for a sincere, honest, and open educational experience. The information presented during the hour was relevant, informative, and useful. The student leaders did an excellent job pulling together information, statistics, and facts that were relevant for their audience and they presented the information using clever, interactive and engaging strategies. The student leaders were poised and professional, yet also demonstrated sincerity, compassion, and honesty in their interactions with my students. They were very well prepared for their presentation yet they were also candid and allowed for organic questions and interactions to unfold.

My students and I appreciated that the presentation was not political and did not include any sort of hidden “agenda” or motives. In actuality, the Consent presentation served to reinforce messages our students begin receiving from school counselors in the primary grades -- messages of self-respect, respect toward others, and when/how to take action or get help when presented with uncomfortable situations.

My students were impressed with the presentation and expressed appreciation the following day for having been allowed the opportunity to learn about issues that “actually matter.” They were surprised by how much of the information was new to them and how many misconceptions they had previously held regarding the realities and legalities of consent. Overall, my students definitely felt the presentation was both educational and enjoyable.

I applaud the efforts of the Planned Parenthood Teen Council members and fully support your efforts to raise awareness in our community and in our schools about issues surrounding violence, relationships, self-efficacy, and teenage health. I hope that you are able to continue spreading the message that each of our students is worthy, deserving, and capable of participating in relationships in which they are valued, respected, and honored.
