There were 22 patients receiving assistance with their special needs during this time period. It is always a challenge for a non-profit to raise the funds needed to assist end of life patients with their special needs. When we receive a grant of this size it is very encouraging to the staff that we will be able to obtain our goals and meet our mission in our valley. For this we thank you for all your efforts on our behalf and our community. Thank you.

In the summer months of 2012 we paid a \$600 electric bill for a patient who would have gone without their A/C.

A husband was on his way to dialysis and was involved in an accident, needed 24 hours caregiver, patient at end stage and needs coverage 24 hours. \$15,688.75

Able to assist one patient while they were medi-cal pending-\$1,372.40, this kind of assistance to patients helps to relieve the burden of payment from them while they are in end stage of life. Our goal is always to assist families when they need monetary relief if at all possible to assist in softening the pain of losing a loved one.
