WHAT


We steward and grow our permanent endowment, The Community Impact Fund, which supports our grantmaking priorities for the region.

We had an incredibly productive year in 2018: hiring our new CEO; recruiting new board members; planning and reflecting on the future of The Community Foundation; and ultimately identifying new initiatives to tackle in our region. After a year-long search process, the Board brought Michelle Decker on as Chief Executive Officer. Michelle came from rural Appalachian Ohio - far from the Inland Empire. Thankfully, she agreed to relocate to the Inland Empire and bring her commitment to grassroots communities, leadership track record and her ability to ask questions and think strategically to enhance the effectiveness of The Community Foundation.

Michelle hit the ground running this year meeting with our donors, fundholders and nonprofit partners. Getting oriented to the entire Inland Empire meant traversing many miles throughout our region, attending important meetings with California's stakeholders and listening, a lot; but it all paid off. Like a vine with good soil and the right amount of rain, by the end of 2018 we

starting bearing quality fruit as we became the Inland Empire's nonprofit leader for Census 2020, embarked on a name change and rebranding effort and revisited our role in higher education attainment with the College Futures Foundation and nonprofit scholarship groups across the Inland Empire and Coachella Valley. Internationally recognized Foundations noticed our efforts to actively engage in the opportunities and issues facing our region and have become important partners, working with us to leverage our assets and assist our region's nonprofits and communities.



PREPARING INLAND AREA STUDENTS TO SUCCEED

The Foundation's Graduate Success Program awarded its first round of strategic, needs-based scholarships to 40 students from Riverside and San Bernardino school districts to pursue their college dreams. Over \$96,000 in scholarships was awarded in 2018. Going forward, the Foundation took new steps toward helping IE students get into college and persist through completion. Helping these students began with expanding the program to include five nonprofit scholarship organizations that offer college guidance services in the communities they know best. These organizations are: BLU Educational Foundation, Promise

In 2017, TCF collaborated with the College Futures Foundation to address low graduation rates in the Inland Empire. The result of this collaboration was Graduate Success, a strategy and fund designed to increase a student's potential to access, thrive, and succeed in higher education by providing needs-based scholarships and college preparation services.

One of the main barriers to college completion is financial need. Many young people have the ability to succeed in college, but lack access to financial resources and college guidance as they transition from high school to 2 to 4-year college programs.

SUPPORTER FOR **DEAF CAUSES**

Gerald "Bummy" Burstein was born deaf in 1926. In spite of a difficult start, Gerald pushed his way through school, eventually teaching at Minnesota School for the Deaf for over 15 years. He then went on to teach at California School for the Deaf in Riverside for 37 years before retiring in 2002.

For much of his life Bummy advocated for deaf individuals with a range of hearing levels. He was a major benefactor to programs and schools serving the deaf. At the advice of his financial advisor, Bummy established three different funds between 2009 and 2018 at the Foundation. The Gerald "Bummy" Burstein Donor Advised Endowment Fund was created to help pay for programs and services to heighten leadership skills for deaf students at the California School for the Deaf, and to

benefit all deaf students living in Riverside County. The other two funds - G. "Bummy" Burstein Donor Advised Fund and G. "Bummy" Burstein Literacy Fund - were established to support the school's library, marquee and related projects. Under the Foundation's stewardship, more than \$29,000 in grants have been awarded to date.

Burstein passed away in 2018, but because of his passion for deaf causes, students in Riverside County continue to blossom into their full potential today.

"It's important to give back," said Burstein in 2012, "and improve students' chances for success as a deaf person in a hearing world."

INVESTING IN OUR COMMUNITY'S NONPROFITS

The Community Foundation invests in our region's nonprofits because they do the work of transforming communities. In 2018, the Foundation awarded \$146,917 in grants to 17 local nonprofits. These one-year capacity building grants were made possible by the Community Impact Fund, which consists of funds that give the Foundation flexibility to support a strong and sustainable community of nonprofits.

COMMUNITY IMPACT FUND

One of those nonprofits is The Children's Discovery Museum of the Desert. Based in Rancho Mirage, the museum is a community resource for children and families to experience the joy of learning through special exhibits and programs. From "Discovery Camp" and "Young Scientists" to "Kids in the Kitchen" and "STEM Nights," these programs inspire a child's natural curiosity about themselves and the world around them.

To continue its mission of serving families in the Coachella Valley, the museum was awarded a Community Impact Grant through The Community Foundation in order to hire a consultant for board education and strategic planning. It was the additional funding they needed to create a three-year plan to support the museum's future growth and organizational effectiveness.

Discovery Museum of the Desert. "The mission of Children's Discovery Museum of the Desert is to be a safe and engaging community resource for all families to enjoy. The Community Foundation has helped us continue to do so."

Started in 1986, the museum celebrates more than 30 years of learning in the desert - serving over 65,000 people per year.

INSPIRING TOMORROW'S PHILANTHROPISTS

At The Community Foundation we believe that sustaining healthy, thriving communities happens when we invest in young people. Started in 2009, the Foundation's Youth Grantmakers program was created to empower Inland Empire young people to address issues that are important to them by learning about and leading the grantmaking process.

The program consists of high school students from Riverside, San Bernardino, Coachella Valley Students awarded five grants to: Big Brothers Big Sisters of the Desert, Birth Choice of the Desert, and Temecula and they're provided money and mentorship to directly fund nonprofit organizations Boys & Girls Club of Coachella Valley, Operation serving youth. During the grantmaking process, SafeHouse and Variety - the Children's Charity they're learning about themselves and developing of the Desert. into civic leaders of tomorrow.

During their year-long training, students learned to read and analyze a grant application, respectfully debated the most critical needs while learning to listen to others' perspectives, and prioritized the many worthwhile requests.

As the program continues to grow, the Foundation is celebrating 10 years of the Youth Grantmakers program in 2019! This special milestone will bring together students, grantees, donors and community partners to showcase the achievements of the past decade and the nonprofit receiving grants for their programs that benefit local youth.
