Dear Friends,

We are pleased to provide you with this year-end tax statement for your 2012 support of Roadrunner Food Bank. Your donations helped us to provide more than 20 million meals total this past year.

This impressive number, though, just tells part of the story. Also during 2012, we were able to:

- Distribute 1,250 Senior Helpings boxes per month to home-bound, medically frail seniors
- Provide 3,495 Food for Kids backpacks per week to elementary school children
- Provide 690 Emergency Food for Families boxes for families in crisis
- Make 94 Mobile Food Pantry distributions per month to more than 27,000 people, many of them in some of the most remote and underserved neighborhoods in the state.

This year we also worked with hundreds of our food assistance partners to begin the next quadrennial Hunger Study - the only study of its kind nationwide that tells us how many people seek help with food each week, what their economic situations are, how many children they have, what their medical status is, and why they need help with food. We will finish this massive project in 2013 and will, with our national organization Feeding America, report the results in 2014.

In the meantime, your generosity is helping to feed seniors, children and working families we see every working day. They are more than numbers to us. We can see the gratitude and relief in their faces every time we are able to give them the food you have made possible. Thank you.

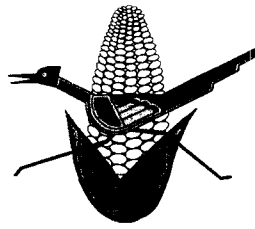
