## **USE OF IP ADDRESSES AND COOKIES**

A unique number called an IP address identifies every computer on the internet. Each time you connect to the internet your machine is assigned an IP address. An IP address is a number that identifies each sender or receiver of information that is sent in packets across the internet. Inland Empire Community Foundation uses your IP address to help diagnose problems with our server, and to administer Inland Empire Community Foundation website.

## SITE FORMS

**Inland Empire Community Foundation's** website registration forms require users to give us contact information (such as name and e-mail address), method of payment, and demographic information. **Inland Empire Community Foundation** may use customer contact information from the registration forms to send the user information about **Inland Empire Community Foundation**. The customer's contact information is also used to contact the visitor when necessary.

#### **CREDIT CARD TRANSACTIONS**

Inland Empire Community Foundation uses carefully selected service providers to process credit card transactions on our behalf. When you provide personal information to process an online donation, your information goes directly from your computer to a server operated by our service provider. Your credit card information is used only to process a "one time" transaction and the provider is bound by contract to treat all of your personal information as confidential. Our credit card service provider provides us with information regarding each completed transaction such as name, address, etc. so that we may record the transaction in our records and provide the donor with a thank you/tax acknowledgement letter but does not share the credit card information with us so that it cannot be processed again.

# **SECURITY**

This site has security measures in place to protect the loss, misuse and alteration of the information under **Inland Empire Community Foundation's** control.

## PROTECTION OF INFORMATION RELATED TO MINORS

**Inland Empire Community Foundation** does not collect information from minors online. Information related to minors is collected from those who complete paper scholarship applications and from those involved in the Youth Grantmakers program.

# **Scholarships**

The Youth Initiatives Manager receives all completed applications, which are filled in a locked cabinet upon receipt. When warranted, copies of applications are made and are hand-delivered or distributed to scholarship reviewers via US Mail. Scholarship reviewers are required to shred the copies of the applications are kept in locked cabinets until they can be shredded per **Inland Empire Community Foundation** Document Retention and Destruction Policy. Access to the applications is limited to the Youth Initiatives Manager and the SVP of Grants and Community Impact.

# Youth Grantmakers (YG) Documents

Application forms and other pertinent documents, including but not limited to: waivers, permission slips, medical and media releases, completed by minors participating in the Youth Grantmakers program are filled in locked cabinets upon receipt. Access to the documents is limited to the YG Advisor, the SVP of Grants and Community Impact, and the SVP of Finance and Stewardship.
